ORDER:-

The Government intends to fill up the vacant posts of Assistant Professors, Associate Professors, and Professors to be notified by the State Public Universities under the administrative control of the Higher Education Department through direct recruitment, covering both regular and backlog vacancies. The recruitment is being taken up as part of the prestigious "Job Calendar-2026" of the Government, reflecting its commitment to strengthen the higher education system and provide employment opportunities in a transparent and timely manner.

2. In the reference 2nd read above, Government issued orders withdrawing the permission accorded vide reference 1st read above and permitted the Sri Padmavathi Mahila Visvavidyalayam, Tirupati to issue fresh notifications for faculty recruitment of vacant posts to be notified with due concurrence of Finance department.

3. In the reference 3rd read above the Commissioner, Higher Education while forwarding the Executive Council resolution of the Sri Padmavathi Mahila Visvavidyalayam, Tirupati, furnished the vacancy position of the number of backlog vacancies and regular vacancies to be filled by direct recruitment and requested the Government to grant permission for issue of recruitment notifications by the concerned university for filling up of faculty vacancies.

4. In the reference 4th read above, the Social Welfare Department has accorded permission to the Higher Education Department to fill up Backlog faculty vacancies (SC/ST/BC) through direct recruitment including the conduct of written test by the Andhra Pradesh Public Service Commission for the screening of candidates for the post of Assistant Professor, and the prescribed recruitment procedure for the post of Assistant Librarian, Associate Professor.

5. Government after careful examination of the matter, hereby accord permission for filling up of 48 (Backlog-6 and Regular-42) vacant faculty positions through Direct Recruitment in Sri Padmavathi Mahila Visvavidyalayam, Tirupati as detailed hereunder:
